PITTWATER AQUATIC CLUB COOPERATIVE LIMITED

Founded 1924 *the oldest and “best little club on Pittwater”*

The PAC is a registered co-operative and as such is governed by the general rules which apply to all cooperatives, the registered PAC Rules set by the members and the By-laws. It is wholly owned and funded by the members.

The total membership is limited to 400, plus life members. This limit is set by the members and is consistent with the facilities which are available for the use of the members. There is no associate membership category.

The club exists entirely for the benefit of its members and activities include weekend cruising, monthly pointscore and yacht racing with Pittwater Sailors, fishing and social events such as the annual club picnic, Christmas party and working bee. The club particularly caters for “do it yourself boaties” and there is a fantastic camaraderie within the club. Pittwater Sailors is the sailing division of the PAC and is open to applicants to the PAC and PAC members.

Facilities available to members include boat and dinghy storage, marina berths, moorings, and slips. Members must apply for use of these facilities and some waiting lists are lengthy. ie: marina could be 10 years.

Other facilities include secure parking, casual moorings in popular locations in Pittwater and the Hawkesbury, dockside work berths with power and water available.

To be considered for membership it is necessary to complete this Membership Application and be nominated and seconded by two members. This form should then be forwarded to the Secretary with the Application Fee.

All applications are added onto a waiting list at the time of receipt, this waiting list is a controlled document that establishes priority and is kept on display in the clubhouse. New members are only admitted as vacancies are created by member’s resignations to maintain the total membership at 400.

Historically 20 to 30 new members are accepted annually. The waiting time to join can vary however generally speaking up to four years can be expected. From time to time the waiting list is closed if this period becomes excessive.

The club is managed by an elected board of directors and functions on a volunteer and co-operative basis where the personal involvement of members in club activities is encouraged. More information can be found on the Clubs website www.paclub.com.au
